4. First aid measures

4.1. Description of first aid measures

General

4.2. Most important symptoms and effects, both acute and delayed

Overview

INHALATION: May be irritating to upper respiratory tract.

SKIN: Low potential of causing irritation following exposure. Not absorbed topically. Some reddening of the skin may occur with lengthy exposure.

EYE CONTACT: May cause mild irritation.

INGESTION: No significant signs or symptoms indicative of any adverse health hazard are expected to occur as a result of ingestion. Large amounts may cause gastric disturbances. See section 2 for further details.

5. Fire-fighting measures

5.1. Extinguishing media
