

**MINUTES OF THE REGULAR MEETING OF THE MIDDLESEX COUNTY UTILITIES  
AUTHORITY —OCTOBER 25, 2022 — 4:00 P.M.**

A Regular Meeting of the Middlesex County Utilities Authority was held at the Authority Board Room, Main Street Extension, Sayreville, New Jersey on Tuesday, October 25, 2022.

The meeting was called to order at 4:00 P.M.

**COMMITTEE REPORTS**

**Finance Committee**

Vice Chairman Wiley reported that a Finance Committee meeting was held on Monday, October 21, 2022 to discuss the Preliminary Budget.

**Engineering Committee**

Commissioner Murray reported that contract awards on today's agenda and the performance of Cogen Plant, which resulted in 81 megawatts to the grid was discussed. Also discussed was the solar array which generates approximately \$1 million in revenue in a 12-month period.

**NEW BUSINESS**

Mr. Cryan reported that the Middlesex County Landfill hosted a successful tour on Saturday with approximately 60 attendees and also acknowledged the Maintenance team at the Wastewater Treatment plant for providing high quality work and saving the MCUA approximately \$200,000 by performing work in house.

Mr. Cryan also recognized MCUA Employee Jodi Litus who presented a paper that he co-authored on remote fiber monitoring system at the Water Environment Federation conference held in New Orleans.


